The Purchaser agrees and understands Route Packages are provided "as is" and Seller makes no representation or warranty as to the suitability of the Route Package for the Purchaser, including, but not limited to, quality of road surface, suggested daily distances, terrain, traffic conditions, accommodation and other services (location, availability or quality), detours, or weather conditions. The Purchaser further understands that routes described in the Route Package are mainly on public roads and users of the Route Package will be sharing the route with motorized traffic and other vehicles and with other users for off-road facilities.
2. All route sheets that form part of the Route Package shall remain the property of Cycle Canada. Reproduction by any means of any material for any purpose, is not permitted. Additional Route Packages may be purchased from Cycle Canada. Route Packages are for non-commercial uses only, this includes rides that raise money for charitable or commercial causes. Purchaser agrees not to use any trademarks owned by CycleCanada without specific written permission from CycleCanada.
3. The total amount is due at time of placing the order. There will no refunds after delivery of Route Package for any reason.
4. The Purchaser acknowledges having understood that there are inherent risks involved in bicycling, including the potential for permanent paralysis and death and that Purchaser in using the Route Package voluntarily assumes such risks. As a condition of the use of this Route Package, the Purchaser, and on behalf of Purchaser's heirs, executors and administrators, releases, waives and forever discharges Cycle Canada, The Veloforce Corporation, and all of its respective agents, officers, directors, employees, successors and assigns of and from all claims, demands, damages, costs, expenses, actions and causes of actions, whether in law or equity, in respect of all use of this Route Package and its contents notwithstanding that same may have been contributed to or occasioned by the negligence of any of the aforesaid.
